LABOUR RELATIONS ACT 1995 ONTARIO

1

Certification.

Scabs Legai.

Reinstatement after a strike - written application by employees within six months from start of strike.

No third party picketing.

OLRB will settle Collective Agreements.

No successor status.

Collective Agreement clause dealing with consultation prior to discipline or firing from Just Cause eliminated.

Where full time and part time employees in one Collective Agreement OLRB will separate.

Two sites - one Collective Agreement - OLRB will separate.

Guards - Security no longer in units.

Crown Employees Act 1993

Gutted.

Employment Standards Act

Termination and severance pay eliminated and maximum compensation lowered from \$5,000. to \$2,000.

Agricultural Labour Relations Act 1944

No longer in force.

Employment Equity Act

Out, and any Agreements with employers under the Act not binding.

Any information gathered under this Act to be DESTROYED.

Also

Human Rights Act and Police Service Act Section for the above Act Repealed.

Workers Compensation Act

Change in composition of Board.

Until changes made President appointed by Lieut Gov. will rule as of November 1, 1995.

Board would be authorized to recover overpayments made to workers, their dependents and employers.

Occupational Health and Safety Act

Board of Directors replaced by Executive Director appointed by Lieut Gov. to manage all operations and functions of the Agency.

Arbitration Criteria

Municipal, School Board and Hospitals - Strikes illegal.

Settlements by Arbitration with following conditions:

Employers ability to pay.

Extent to which services reduced if funding levels reduced.

Provincial, Municipal/Local Economic Environment.

Wages comparable to Public and Private Sector.

Employers need for qualified employees.
